Practice Overview

Daniel Jowell KC is one of the Bar's foremost silks for both commercial law and competition law.

His practice spans all aspects of commercial law and competition law, including commercial judicial review. He is highly ranked in multiple categories of the legal directories, in which he has recently been described as an "excellent advocate" who is "super in court" with "exceptional judgement", and "incredibly clever and a great team player" (Chambers & Partners, 2025). He has experience at all levels of the court and tribunal system and has also appeared in a number of major international commercial arbitrations.

His current and former clients for whom he has acted in reported cases include companies such as Visa, Meta and Qualcomm, as well as individuals such as Roman Abramovich and Bernie Ecclestone.

He was awarded Chambers & Partners' Competition law "Silk of the Year" for 2025 and was one of six KCs to appear in the Lawyer's "Hot 100" 2025.

Commercial

Daniel practises across all aspects of commercial law and is particularly well known for his experience in international commercial disputes involving conflicts of law or foreign law. He has extensive experience in joint venture disputes and in challenges to jurisdiction. He is also noted for his work in the energy sector where he is "experienced across the run of energy regulatory work and straight energy work." Competition

In addition to his commercial practice, Daniel Jowell KC has long been known as "one of the best competition silks around" (Chambers and Partners 2016) giving "the clearest and best strategic advice of anyone at the competition Bar" (The Legal 500 2022).
