Jessie practises across all aspects of Commercial, Public and International law. Jessie has experience and a particular interest in investment treaty arbitration, public international law, international human rights law, civil fraud, and sanctions.

Jessie is ranked as a "Leading Junior" in Commercial Litigation and a "Rising Star" in Civil Fraud by Legal 500. She has also been appointed to the Attorney General's C Panel for Public International Law.
