Practice Overview

Richard Eschwege practises in heavyweight litigation and arbitration; he has acted in some of the highest profile and most significant cases of recent years. He has a broad, predominantly commercial, practice, and has advised on and acted in a spectrum of disputes, including energy and natural resources, banking and financial services, civil fraud, insurance and reinsurance, professional negligence, telecommunications, conflicts of interest, conflicts of laws, and jurisdiction battles. He has appeared in the national courts at all levels and before many international arbitral tribunals.

Richard took silk in 2023. He is ranked in the legal directories as a leading silk in Commercial Dispute Resolution, Energy and Natural Resources, Banking and Finance, Civil Fraud, Insurance and Reinsurance, and International Arbitration. He was one of *Legal Week's* 'Stars at the Bar' and was Banking Barrister of the Year at Lexology's European Awards 2025. He was shortlisted for Barrister of the Year in The Lawyer Awards 2025 and in Commercial Dispute Resolution by Chambers and Partners 2025.

Richard has a particularly strong practice in disputes relating to energy and natural resources, banking and finance, reinsurance/insurance and civil fraud matters.

He has acted in a large number of substantial oil and gas, mining or infrastructure disputes across the globe, including in the North Sea, Eastern Europe, the Middle East, central Asia, the Americas and central and west Africa. He has appeared in many of the major energy and natural resources cases of recent years, including *Excalibur Ventures*. Richard has appeared in *Município de Mariana v. BHP*, a £36 billion claim arising from the collapse of a Brazilian dam; it is the largest group litigation ever before the English Court. He recently successfully defended the principal defendant CEO and CFO in *Alta Trading (formerly known as Arcadia Petroleum) v. Bosworth*, a US\$500m alleged fraud concerning West African oil trading. After a 10-year battle fought in courts in England and

abroad and a 3 month trial, the Commercial Court dismissed the fraud claim against Richard's clients on all grounds.

Richard has worked on a variety of banking litigation matters, often involving complex financial products. He has acted for lenders, borrowers, hedge funds and other fund management companies, in a wide range of financial disputes, including asset and security enforcement, the restructuring of facility agreements, repos, disputes under bank guarantees, disputes involving bond issues and clearing systems, LIBOR manipulation, swaps mis-selling cases, and payments under letters of credit. He has experience of insolvency matters and had involvement in proceedings arising under the Takeover Code or investigations involving regulators.

Richard also has extensive experience of civil fraud matters, both for claimants and defendants, and frequently in the context of multi-jurisdictional disputes. In addition to his work in *Alta Trading*, he currently acts in a number of other substantial fraud cases that are before the English court.

Commercial

Recent court matters on which Richard Eschwege has been instructed include:

- *Alta Trading UK Ltd (formerly known as Arcadia Petroleum) v. Bosworth & Ors* [2025] EWHC 91 (Comm.); [2021] EWCA Civ. 687; [2020] EWHC 2757 (Comm.); CJEU [2019] ILPr. 22; Supreme Court, April 2017; [2016] EWCA Civ. 818; [2016] EWHC 2527 (Comm.); [2015] EWHC 3700 (Comm.); [2015] EWHC 1030 (Comm.): Richard successfully acted for the principal defendants in a 3 month trial in summer 2024 in respect of an alleged oil trading fraud in West Africa. The Claimants alleged that the principal defendants had dishonestly diverted profits of US\$325m as part of a massive fraud; with interest on the alleged diverted profits, the Claimants claimed US\$502m. There were allegations of conspiracy, dishonest breach of fiduciary duty and dishonest assistance, as well as Swiss law claims. The Commercial Court gave judgment in early 2025, dismissing the fraud claim on all grounds, and describing the Claimants' allegations as 'untenable'. This matter was previously the subject of a complex and long-running jurisdiction challenge (which went to the Court of Appeal twice, the Supreme Court and the CJEU) concerning the interpretation of matters relating to employment contracts. There have been numerous interlocutory applications including in respect of disclosure and enforcement of freezing orders outside the jurisdiction.
- *Município de Mariana v. BHP Group (UK) Limited* [2023] EWHC 2607 (TCC); [2023] EWHC 2030 (TCC); [2023] EWHC 1134 (TCC); [2022] EWHC 330 (TCC): Richard acted for one of the defendants in a £36 billion dispute, the largest group litigation before the English court, arising out of the collapse of a Brazilian dam. In addition to defending the substantive claim, Richard acted in a jurisdiction challenge and arbitration stay application.

- *MWB Group Holdings* (Takeover Panel, July 2024): Richard acted in disciplinary proceedings brought by the Takeover Panel for breaches of the Takeover Code arising out of the dealings in shares of MWB Group Holdings Plc. The proceedings were the most substantial and complex set of proceedings that the Panel has ever brought.
- *Instituto De Salud Para El Bienestar v. Viva Enterprises Ltd* (2024): Richard acts for the defendant in an US\$40m dispute concerning alleged fraudulent misrepresentations and the delivery of medical ventilators to Mexico during the Covid-19 pandemic.
- *Kireeva v. Zolotova* [2024] EWHC 2705 (Ch): Richard acted in bankruptcy proceedings arising from a £1.34bn fraud. This particular dispute was a sub-set of the bankruptcy and related to the ownership of a valuable Italian villa; claims made for relief as to the beneficial ownership and/or in respect of transactions at an undervalue for the purposes of s.423 Insolvency Act 1986.

Antoshin* [2023] EWHC 86 (Comm.); [2022] EWHC 3182 (Comm.); [2022] EWHC 2667 (Comm.): jurisdiction challenge in US\$40m dispute over an alleged shareholding agreement; setting aside claim form because change of jurisdictional basis for service out was an abuse of process; striking out contempt applications.
- *Maranello Rosso v. Lohomij* [2022] EWCA Civ. 1667; [2021] EWHC 2542 (Ch): scope and effect of a settlement agreement compromising claims in alleged £70m conspiracy relating to a rare collection of Ferrari classic cars; rights and obligations of secured creditors.
- *Bank St Petersburg v. Arkhangelsky* [2022] EWHC 2499 (Ch) [2020] EWCA Civ. 408; [2018] EWHC 1077 (Ch.): Richard acted for the successful bank in a substantial and long-running dispute concerning the enforcement of bank guarantees and alleged US\$380m fraudulent banking 'raid' on companies' assets.
