Practice Overview

Tony is a commercial mediation pioneer, among the first to be trained in 1990, to mediate regularly and then in 1998 launch his own independent practice as a full time commercial mediator as the Woolf Reforms to Civil Justice were about to take effect.

His background as a Litigation Partner in Clifford Chance for more than 25 years (including a 2 year stint as a Managing Partner), managing teams of Lawyers in some of the most complex multinational litigation gave him the experience and standing to undertake a wide range of commercial matters. He was an early member of the International Academy of Mediators, has mediated widely in the UK and elsewhere in Europe, in the US, the Caribbean, the Middle East, Hong Kong and elsewhere and has been recognised by all the prominent legal directories including some years as Commercial Mediator of the year by WWL.

Tony joined chambers in 2004, so joining Bill and Stephen in what even then was an exceptional group of UK based full time professional commercial mediators.

Mediation
