## Practice Overview

---

Vernon Flynn QC is a "superstar" and "veteran of many heavyweight litigation battles". He has a wide ranging practice in international and domestic commercial law "at the highest level" or "in the premier league". He has extensive experience of trial work and appellate advocacy and has unusually extensive experience of civil tribunals (often where the substantive or procedural law is not English law). He is frequently instructed in very high value, multi-jurisdictional disputes across the globe.

Vernon is particularly noted for being a "powerful courtroom leader" with a "brilliant courtroom manner", "a superb advocate who presents cases in a clear and authoritative manner", "who really impresses judges" and whose "advocacy is very powerful and persuasive" and also noted for his "fantastic courtroom demeanour" and "amazing ability to make complicated things simple", his "sharp, tactical mind", "a great blend of intellectual analysis and practical guidance through complex cases", his "commercial and strategic mindset" and "fantastic way with the judges" and for being "superb with clients" and "a good team player".

Vernon has a global and diverse practice in *“big ticket”* multi-jurisdictional disputes. His cases have ranged from substantial trial and appellate advocacy to injunctive or other interim relief before a very wide range of tribunals and jurisdictions. They have involved appearances in many jurisdictions such as Anguilla, Australia, Cayman Islands, Gibraltar, India, Hong Kong, Qatar, Seychelles, Singapore, St Lucia, Sweden, Tanzania, the Virgin Islands, and the United Arab Emirates.

He continues to maintain a broad practice, including acting in the Luna yacht jurisdiction challenge in Dubai which was part of the UK’s largest divorce settlement, acting for the 9/11 victims in the UK commercial court, personal counsel to the then Chancellor of the Exchequer in the Leveson Inquiry, the original gas dispute between Russia and the Ukraine, the Ecuadorian Indian dispute with Chevron and acting for the Ruler of the UAE in a case in the Seychelles involving sovereign immunity amongst many other cases.

He has acted for numerous states, heads of state, state entities, major companies and wealthy individuals. He has been doing Russian and CIS work since the mid 1990s. His client list extends across the entire globe. Many of his cases concern clients from Russia or the CIS countries, the Far East, the Middle East and Africa. Much of his offshore work is China related.

In the first quarter of 2021, Vernon appeared in 6 appeals: one Privy Council appeal (which concerns the Bahamian Arbitration Act), two DIFC CA hearings (one concerning the application of the Torrens registration system in the DIFC and the other concerning the statutory jurisdiction of the court – having appeared in most of the prior decisions on the issue), and three separate ECCA appeals on appeal from the BVI. He has also appeared in 5 separate applications for Pakistan in the Tethyan dispute (which is a \$6 billion dispute arising from an ICSID award).

Work in 2019–21 has included resisting enforcement of an arbitration award in the Cayman Islands (CICA), acting in the Virgin Islands aspect of an international fraud (JTrust), a Russian/Armenian mining arbitration (Vallex), the Baring Vostok dispute (which was the case involving the house arrest of Michael Calvey in Moscow), a contempt application in the long running Ng case in the VI, the UKCA in the Koza case which concerned the national court’s role in ICSID arbitrations and a second appeal on abuse of process, the Essar Steel decision in Cayman which deals with Norwich Pharmacal relief and the different

approaches taken by the Cayman and English courts, a DIFC hearing in a DIAC dispute, acting for Pakistan in the Karkey enforcement dispute, acting for India against Reliance Industries, acting for energy companies against Pakistan in the commercial court, acting for China Shanshui in Cayman winding up proceedings, acting in a hotel dispute in the DIFC which defines the scope of the contempt jurisdiction of that court, a trial before the UK commercial court on rectification (involving the placement of a comma in a clause), an ICC arbitration between an Uzbekh and Chinese state entity, the Paraskeviades decision in the ECCA which concerned the obligations in relation to ex parte relief in the BVI.

Vernon has particular expertise in international arbitration under most institutional rules both as arbitrator and counsel and the commercial aspects public international law. "*The "absolutely brilliant" Vernon Flynn QC is an "excellent advocate with an encyclopaedic knowledge of English arbitration law."* He has appeared in many of the important cases under the 1996 Act including *Fiona Trust*, *Azov Shipping v Baltic Shipping*, *A v B*, *Cetelem v Roust*, *Koza*, *SAB Miller*, *Nomihold v MTSF* and *Westland Helicopters*. He was a Visiting Fellow of the London School of Economics from 2003 to 2009 on the LLM course, International and Comparative Commercial Arbitration, which course he co-founded.

He occasionally sits as arbitrator in interesting cases (such a mining dispute involving an African state in a claim in excess of US\$35 billion and a Nigerian dispute with Lord Neuberger and Judith Gill). He was co-arbitrator with Lord Hoffmann in one of his first arbitrations.

Other notable cases include *ICS v West Bromwich*, *Stocznia Gdanska v Latvian Shipping*, *Canada Trust*, *Buncefield*, *Nomihold*, *Baring Vostok*, *Ablyazov* and *Ecobank*.

Vernon was a black belt karate instructor at Cambridge University and won a gold medal at the BUSF games.
