## OVERVIEW

Since retiring from the Bench in 2012, His Honour Nicholas Chambers QC has developed his practice as an Arbitrator and Mediator. He has sat regularly as a single arbitrator, third arbitrator or panel member in a wide variety of disputes including claims in respect of joint enterprises, shipping and television broadcasting rights. He has also acted as a mediator in commercial disputes of all kinds including banking, shipping, aviation and IP.

He is a former Mercantile Judge for Wales and sat in the Commercial Court, Chancery Division, Technology and Construction Court and Queen's Bench Division. He was authorised to sit in the Admiralty Court.
