#### International Arbitration

Hilary Heilbron also practices international arbitration in which she appears both as counsel and acts as arbitrator. She speaks regularly to international audiences and writes on the subject. As counsel she also takes court related arbitral cases. She has chaired many tribunals of leading international arbitrators. Her appointments have been under ICC, LCIA and ICDR as well as ad hoc appointments. Many of these relate to substantial claims including in excess of US 1 billion. She also has experience of arbitrations in many foreign laws: both civil and common law. She has also been appointed as an emergency arbitrator by the AAA (ICDR rules) under their Article 37 procedure. She is a member of the LCIA Court. She also trains arbitrators for the ICDR, and was a speaker at Singapore International Arbitration Academy Advanced Training Programme in December 2012. Hilary was quoted in Who's Who Legal 2016 as being an "absolutely fantastic arbitrator" whose experience includes ICC, LCIA and ICDR and ad hoc appointments."

### Litigation
