Practice Overview

David Bailey KC was called to the Bar in 2012 and took silk in 2026. He was called to the Irish Bar in 2018.

David specialises in competition and EU law. He acts for both Claimants and Defendants in follow-on and standalone claims as well as collective proceedings. David has appeared in many competition law claims including in *Streetmap v Google*, *Gemalto v Renesas*, *Stellantis v Autoliv*, *Euronet v Mastercard and Visa*, *Veolia v MAN* and *Sports Direct v Newcastle United*.

He is currently instructed in various collective actions in the Competition Appeal Tribunal, including those in *Trucks*, *FX*, *RoRo*, *Meta*, *Qualcomm*, *Yorkshire Water*, and *Loyalty fees*. He appeared unled in *RoRo* defending MOL in the first follow-on collective claim to go to trial for nine weeks. The claim was for up to £215m damages arising from a cartel in the intercontinental shipping of new cars.

David has been Standing Counsel to the UK Competition and Markets Authority since 2015. He has appeared in some of its most important and high-profile cases, including *Paroxetine*, *Phenytoin*, *Liothyronine*, *Hydrocortisone* and *Microsoft/ActivisionBlizzard*. He has been instructed to act for the CMA in its interventions in *Le Patourel v BT*, *Phone 4u v EE*, *Kent v Apple* and *Coll v Google*. David has also acted for the European Commission, the Irish Competition and Consumer Protection Commission, the Competition Commission of Singapore and the Competition Commission of Mauritius.
