## Practice Overview

David is recognised as a leading silk in competition law, regulatory/life sciences law and EU law.

Current and recent editions of the Legal 500, Chambers & Partners and Chambers Global describe him as *"a fierce and fearless advocate ... incredibly hard-working and approachable, and he wins the most complex cases"*, *"exceptional"*; *"a class act"*; *"a great advocate"*; *"a fantastic trial advocate"*, *"extraordinarily able"*; *"superb"*; *"fearless"*; *"a first-rate KC"*; *"extremely effective with judges and clients alike"*; *"at the top of his profession"*; and as *"one of the most knowledgeable competition lawyers I have ever had the pleasure of working with"*. ### Competition Law

In standalone claims, he acted for Autoliv in the successful dismissal of Stellantis's €771m claim alleging cartel losses arising from the purchase of Occupant Safety Systems, following a 5-week trial (*Stellantis v Autoliv*, CAT, 2025) and for Orange SA in the successful dismissal of Phones 4U's claim against mobile network operators (*Phones 4U v EE*, CAT and Court of Appeal). He currently acts for Epic Games in *Epic Games v Alphabet and Google*, which will be heard by the Competition Appeal Tribunal in 2026, together with *Coll v Alphabet and Google* and *Rodger v Alphabet and Google*.

In follow-on damages claims, recent and ongoing instructions include acting on the Defendant side for *Sun/Ranbaxy* in the *Citalopram* follow-on brought by the NHS (ongoing, CAT) and for *SalMar* in

the *Salmon* (UK Supermarkets) claims (ongoing, CAT). On the Claimant side, he acted in both the *CRTs* and *DRAMs* follow-ons (both now successfully settled). He acted for the defendants in *Power Cables* and *Refrigeration Compressors* (both in the English courts) and in *Elevators & Escalators* (in the European Courts).

In collective proceedings, he acts on the Claimant side for RHA Used Trucks (RUTL), having successfully secured the UK's first opt-in collective-proceedings order, in proceedings arising from the *Trucks Cartel* (ongoing, CAT), and on the Defendant side for *SalMar*, in the *Salmon* (Collective Proceedings) claims (ongoing, CAT). He has acted as leading counsel in many of the most important regulatory appeals from decisions of the CMA and Ofcom, including in *Prochlorperazine* (for the successful Cinven Appellants), for *Sky* (again, successfully) in *Pay TV* and for GlaxoSmithKline in the 'Pay-for-Delay' litigation.

He acted for the defendants in *Power Cables* and *Refrigeration Compressors* (both in the English courts) and in *Elevators & Escalators* (in the European Courts) and for GlaxoSmithKline in the 'Pay-for-Delay' litigation. He has extensive media mergers experience.

#### Regulatory and EU law

David is listed in Chambers and Partners and the Legal 500 as one of the country's foremost specialists in both life sciences (UK and EU pharmaceutical regulation) and EU law. He is described by C&P 2026 as "*amazing. His knowledge is encyclopaedic; he is incredibly quick to see how regimes fit together*" and as "*a proper EU specialist ... a real regulatory and constitutional scholar*".

He recently acted for Guilin in its successful judicial review of the Foods Standards Agency and Foods Standards Scotland, resulting in the reclassification of monk fruit across the UK and the EU (*R(Guilin) v Food Standards Agency* (Admin.), 2024); and, again successfully, in *ABOCA and Others v Commission* (General Court, 2024, quashing a Commission Regulation annexing hydroxyanthracine derivatives to the Additions Regulation). Further recent instructions include: *Easynet* (Court of Appeal); *ViiV Healthcare v European Medicines Agency* (General Court); *Symrise v European Chemicals Agency* (General Court); *AbbVie v European Medicines Agency* (General Court and Court of Justice); *PTC v European Medicines Agency* (General Court and Court of Justice); *GE Healthcare v Commission* (General Court); *Aer Lingus v Commission* (General Court); and *R(British American Tobacco) v S/S Health* (Admin. Court, Court of Justice and Court of Appeal).

His PhD (Cantab.) addressed the EU's common foreign and security policy. David was the UK's representative on the CCBE's Standing Committee to the Court of Justice. He continues to sit on the Bar Council's EU Law Committee and on its Trade and Cooperation Agreement Sub-Committee.

David is a member of the Irish Bar (2017), enabling him to continue his representation of parties

before the European Court of Justice. Before taking silk, David was a member of the Attorney General's 'A' Panel of Counsel to the Crown.
