### Practice Overview

---

Firdaus practises across all areas of commercial law, as well as in competition law. His notable current and recent experience includes:

- ***Rusal v Whiteleave, Potanin, Crispian, and Abramovich***: Ongoing Commercial Court civil fraud proceedings concerning the management of Nornickel, the world's largest producer of refined nickel (acting for Whiteleave and Mr Potanin, on a team led by Tim Lord KC). The fourteen-week trial is scheduled to commence in April 2027.
- ***Palmali Shipping v Litasco***: Six-week US\$ 170 million Commercial Court trial in January-February 2025 brought against the trading arm of Russian oil giant Lukoil, for non-delivery of cargo under an alleged contract of affreightment (acting successfully for Litasco SA, on a team led by Tim Lord KC). - ***Alex Neil Class Representative v Sony Interactive Entertainment***: Ongoing CAT collective proceedings alleging an abuse of dominant position in respect of Sony's operation of the PlayStation Store, said to have caused losses in the region of US\$ 5 billion (acting for Sony Interactive Entertainment, on a team led by Daniel Beard KC). The ten-week trial is scheduled to commence in March 2026.
- ***Greensill Bank AG v Secretary of State for Business and Trade***: Ongoing £350 million Commercial Court proceedings brought by the Insolvency Administrator of Greensill Bank AG in respect of the Secretary of State's termination of certain Covid-19 loan guarantee agreements (acting for Greensill Bank AG, on a team led by Tim Lord KC). The eight-week trial is scheduled to commence in January 2028.

Firdaus is also developing an unled practice. Selected recent instructions include acting for a

Zambian financial technology company in an LCIA arbitration worth US\$ 1.3 million, and for a shareholder in a major sports franchise in a deceit claim against a German bank.

Prior to coming to the Bar, Firdaus read law at St. John's College, Oxford, where he secured the second highest mark in the university, as well as the highest in the private law modules. He then undertook the BCL, followed by the Bar Course at the Inns of Court College of Advocacy, being awarded further scholarships and prizes along the way.
