## **Practice Overview**

Jacob is developing a broad practice, focused primarily on commercial and competition litigation.

He has particular experience in large multi-party disputes, notably in claims brought by shareholders under FSMA and claims for 'follow-on' damages following infringements of competition law.

He also has a developing sports law practice, having acted in a range of disputes involving competition law challenges to rules and regulations adopted by sports governing bodies.

## Commercial

Cases in which Jacob has been or is instructed include:

- Claims under s.90A and s.90 (acting for the Defendant): Financial List claims under s.90 and s.90A of FSMA against an energy company.
- Claims against a law firm (acting for the Defendant): A series of High Court claims against a major multinational law firm in relation to the alleged conduct of several former partners.

- Acted for the Claimant (as sole counsel) in a claim in the High Court seeking payment under a profit-share agreement in relation to development projects.

- Advised a sports governing body in relation to a competition law challenge to, *inter alia*, the rules applicable to the authorisation of alternative leagues and tournaments.

- Advised a telecommunications company in relation to regulatory proceedings concerning alleged breaches of competition law.
