Practice Overview

Laura Newton has a commercial practice which sees her regularly instructed in high value international commercial disputes and arbitrations, often with a fraud aspect.

Laura took silk in March 2026. Out of the 96 new silks appointed, she was one of just 10 new silks highlighted and profiled by Legal Business magazine as the "ten names to note".

Prior to taking silk, Laura won Commercial Litigation Junior of the Year at the Legal 500 Bar Awards in September 2025 and was nominated for that award by both Legal 500 and Chambers & Partners in 2023. She also won Returner of the Year, as one of the Outstanding Women in Law, in the 2024 Women and Diversity in Law Awards. Previously she has been selected for inclusion in *The Lawyer* Hot 100, and was also featured as one of the *Legal Week* 10 Stars at the Bar.

Laura's recent instructions include appearing in the Court of Appeal (and a forthcoming appeal to the Supreme Court) for the National Iranian Oil Corporation in a \$2bn dispute raising issues of agency, insolvency and trust law; acting as sole counsel in the Privy Council in relation to an appeal concerning directors' disqualification in Montserrat; acting as sole counsel in substantial LCIA and LMAA arbitrations; and appearing for the successful Appellant in the Privy Council in relation to an issue of Trinidad & Tobago banking law. She has previously acted for a number of lenders in proceedings arising out of the \$2 billion "tuna bond" scandal involving allegations of bribery and corruption in Mozambique; for a City law firm in proceedings arising out of hacking of a businessman's data; and for a group of Chinese banks in a \$700 million claim against the Indian businessman Anil Ambani. She is also admitted to the Bar of the Eastern Caribbean Supreme Court.

Commercial

Laura's practice consists of substantial commercial cases, most of which have an international aspect. Under the umbrella of commercial litigation, Laura's practice spans contractual disputes, civil fraud, banking and finance, and professional liability. She has substantial experience of interlocutory applications, including freezing injunctions, search orders, Norwich Pharmacal relief and other interim measures.

Laura also has experience of shareholder disputes, applications against directors, applications under the Companies Act 2006, applications under the Insolvency Act 1986, and advising in relation to company law issues.
