## Practice Overview

---

Mark Cran KC has developed an impressive practice within the field of commercial law. Given his strong advocacy experience and command within the court room, he is well-known as a very effective cross-examiner and a persuasive advocate. His practice additionally covers specialist areas such as banking, entertainment and media, licensing & gaming, sports law, insurance and reinsurance, European law, and public and administrative law.

Mark Cran KC is currently a door tenant of Brick Court Chambers, and is Senior Counsel at leading Bermudian firm Attride-Stirling and Woloniecki. He was a full tenant of Brick Court Chambers 1974 - 2013.

## Commercial

Highly experienced as a commercial advocate, he regularly appears before the Admiralty and Commercial Court, the Court of Appeal, and before various Arbitration Panels on high value claims. He is recognised in the area of Commercial Litigation as a leading silk in the Legal 500. In recent years he has been instructed in several major Chancery commercial actions. [In 2007-9, Mark Cran KC largely withdrew from practice due to the serious illness of his partner.]

He advised Williams and McLaren on the proposed flotation of F1A by the Ecclestone interests, a matter which required an appreciation of EU Competition law. More recently he was instructed on behalf of the Stanford interests in the dispute between the West Indies Cricket Board, the EWCB, and Digicel over the broadcasting and staging of the Stanford 20/20 cricket matches in Antigua,

prior to the detention and trial of Sir Allen Stanford.
