Practice Overview

Sarah Abram KC was called in 2006 and took silk in 2022; she is described in the directories as "a wonderful advocate who always has the ear of the court", "a smiling assassin in cross-examination" "very calm under pressure" and "very strategic and focused" as well as having an "[i]ncredible knack of being on top of everything all of the time".

Sarah is a leading competition, EU and commercial law silk. Recent and current highlights include:
